Women narrowly get the right to vote after a 72-year struggle. All women of color, 1965

— 2010's —

Birth control is more accessible, abortions fall to all-time lows. Most female contraception remains prescriptive, while men's is over-the-counter **— 1963** -

Equal pay act\* signed into law. However, the gap remains at 25.2%

**— 2023 —** 

The U.S. recorded an estimated 11% increase in abortions over 2020 (pre-Dobbs) levels

Men can be convicted of raping their wives, even without use of a weapon, in all 50 states

Child marriage still legal in 46 states, only 12 states fully ban it

The U.S. ranks ~70th globally for women's representation in national legislatures — far below countries like Rwanda (61%), Mexico (50%), or Sweden (46%).

According to the World Economic Forum's Global Gender Gap Report 2024, the U.S. is ranked 43rd out of 146 economies in overall gender equality.

# Many states still lack equal rights amendments in their constitutions; the federal ERA remains unratified.

#### It states in full:

#### Section 1.

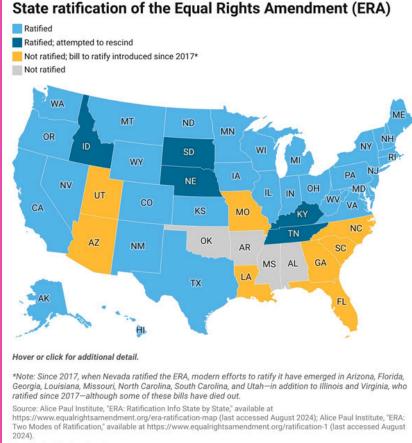
Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.

#### Section 2.

The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

#### Section 3.

This amendment shall take effect two years after the date of ratification.



### In Simple Terms

- Proposed: 1923
- Passed Congress: 1972
- 38 states ratified: by 2020
- Deadline expired: 1982
- Status today: Not officially part of the Constitution yet.

Even though women in the U.S. gained suffrage in 1920, most laws securing financial independence, bodily autonomy, and workplace equality came decades later many within living memory.

The pattern is clear: women's rights progressed in waves of reform, often triggered by lawsuits or activism that exposed how deeply inequality was still written into law.

Even though women's rights have expanded through individual laws (Equal Pay Act, Title IX, Pregnancy Discrimination Act, etc.), none of these are constitutional guarantees.

#### Without the ERA:

- Sex discrimination isn't explicitly banned by the Constitution.
- Rights can shift with changing political or judicial priorities.
- The 14th Amendment's "equal protection" clause has been used for gender cases — but it was written to protect formerly enslaved men, not women.

The ERA would anchor gender equality as a permanent, explicit constitutional right, not something dependent on interpretation or legislative mood.

about 78% of Americans support ratifying the ERA (Pew, 2024).

In 2025, Defense Secretary Pete Hegseth reposted a video from pastors in a Christian nationalist church asserting that women should no longer have the right to vote and should instead vote as households or under male authority.
